HOW TO CLAIM

What is Universal Credit?

Universal Credit is administered by the Department for Work and Pensions (DWP) and aims to make the welfare system simpler by replacing six benefits and tax credits with a single monthly payment.

Universal Credit replaces:

- Housing Benefit
- Income Support
- Income-based Job Seekers Allowance
- Income-related Employment & Support Allowance
- Child Tax Credits
- Working Tax Credits

How to claim Universal Credit

To apply for Universal Credit at **www.gov.uk/universal-credit** you must have a bank account and an email address.

Remember to include details of your rent when you claim Universal Credit so that your housing costs are included in your claim.

You will be given an online account to manage known as a journal which you will be advised by DWP how and when to access.

There is a list of documents and information DWP will require at your first appointment (please see the back of this leaflet).

Council tax reduction

Your claim for Universal Credit does NOT include any council tax reduction you may be entitled to. Once you have made a claim for Universal Credit, you must make a separate claim to Dundee City Council for your council tax reduction.

How will you manage while you wait for your first Universal Credit payment?

If you're going to struggle financially whilst waiting for your first payment, you may be entitled to an advance payment from the DWP while your claim is being assessed. This will then be recovered from your future monthly payments.

Additional help with rent costs

If your Universal Credit award includes housing costs you may be eligible for a discretionary housing payment to help with your rent and/or bedroom tax.

The Scottish Welfare Fund

If you need help to set up/stay in your home, or you or your family have been hit by a crisis, you can apply for a crisis or community care grant.

Need help to budget?

MANAGING YOUR PAYMENTS

Universal Credit payments


Universal Credit is paid monthly in arrears direct into your bank account including any housing costs you are entitled to. You may be able to ask for twice monthly payments or for your housing cost to be paid direct to us as your landlord. As you are an Abertay tenant, it is essential that you contact the rent team immediately to discuss your payment options.

Paying your rent

Paying your rent on time and in full is the most important part of your Tenancy Agreement.

There are lots of payment options to choose from, including direct debit, so we can discuss what option would be best for you.



Pay to Stay

It is your responsibility to ensure that your rent is paid on time and to contact the Rent Income team if you are experiencing financial difficulties.

Failure to deal with rent arrears could result in legal action being taken against you and you could be at risk of losing your home.



GETTING ONLINE

Need access to a computer?

If you don't have a computer at home, free access and WiFi is available for public use at council offices and libraries across Dundee. One Parent Families Scotland and Abertay also run a computer class and have laptops available for tenants at 87 G/R Fintryside.

You can come in for advice and assistance on using them, or if you need to just gain access to the web you can check your emails, manage your UC claim and browse freely.

If you need help to use a computer or to make your claim we can arrange for a member of staff to help you.

You can drop by to make your claim for Universal Credit or to access your Universal Credit journal.

What I need to do now checklist

Inform the Department of Work and Pensions (Universal Credit):

that Abertay is your landlord

Apply to Department for Work & Pensions for:

an advance on my first Universal Credit Payment

Arrange:

access to a computer help using a computer



Apply to Dundee City Council for:

- my council tax reduction
- a discretionary housing payment to help with my rent costs/bedroom tax
- a Scottish Welfare Fund payment to meet expenses.

Arrange:

- how I am going to pay my rent
- how I am going to pay my council tax
- personal budgeting support to help manage a monthly budget



Notify Abertay Housing Association:

if my Universal Credit claim stops or changes **or** if my household circumstances change

Universal Credit Checklist

Before starting the Universal Credit claim you will need to know the following information...

Full name and postcode and contact details
National Insurance Number – You can phone 0300 200 3500 if they can't find it.
Details of the bank or post office account where you would like the UC payment
made (Sort code and Account Number)
Details of other capital or savings (e.g – other bank accounts/premium bonds /
shares, etc)
Details of income (e.g – earnings, pensions, income from an insurance plan,
benefits, etc – How much/frequency)
The type of accommodation you live in (e.g – rented from Abertay Housing
Association.
Our landlord address and telephone number
How much rent you are liable to pay – this will be on your tenancy agreement
The date your tenancy started – this will be on your tenancy agreement
Childcare cost amounts (if applicable). Childcare must be provided from an
approved childminder
If you get Child Benefit for any of your children you will need your child benefit
reference numbers, these start with CHB and can be found on bank statements or
child benefit letters. You can phone the Child Benefit Office on 0300 200 3100 if
HIEV HEED HIE DETAILS HOLL VOU.

The DWP will then need to verify the above details at your first appointment. Try to take along as much documentary evidence as possible to help your claim run smoothly. If you cannot get all the documents then you should still attend the appointment so the local Jobcentre staff can advise you; usually they will book a further appointment to allow you some time to gather the documentary evidence.
